HOLSTON PRESBYTERY CAMP AND RETREAT CENTER REPORT was given by Jim Austin. An Indian Summer has extended warm, dry weather in the High Country. The camp has been busy with several sewing guilds and church groups. The schedule remains busy through November.

An E-Mail blast has been distributed to our mailing list with the following promotions:

- We are offering special rates to our Holston Youth Group retreat on November 11-13. We want to promote our facility and ministry especially to this group.
- Our Christmas Party will be December 3 -4 with special (1-night, 2-meals) rates.
- December is typically slow. We hardly have any reservations for December so we have a 30% off promotion for any retreats booked in December.

Sunday, November 20 the Camp will host the annual Community Thanksgiving Potluck Dinner at the Dining Hall at 5:30 pm.

With Presbytery approval, the Camp will begin raising funds to renovate the oldest 5 rooms in Guenther Lodge to provide 4 rooms with private bathroom facilities.

The Camp Task Force is making advances on plans to develop the Upper Meadow. It has asked David P. Moses, Architect, for a contract to survey the property and establish various parameters for development. Estimated cost \$10,000 to \$12,000.

We have begun renovation of the Dining Hall apartment including new floor covering, wiring, paint and cabinets. Estimated total cost is \$6,000. This can serve as a private apartment for guests or the weekend host.

Chris Robertson, 2016 camp counselor and a member of Covenant Church, has been serving as the weekend host.

After an evaluation by a stone mason, 5 chimneys will be repaired and weather sealed. The original chimney in the Lodge needs to be either rebuilt or taken down. The Manse chimney needs additional work.

Lisa Jones and I attended the PCCCA Annual Conference at Ferncliff Camp and Conference Center in Little Rock Arkansas on November 6-11.

I have completed the first course in my CRE training, Reformed theology with The Reverend Paul Helphinstine of Covenant Church.

Generally, the camp is in good shape, finances are stable, and employees are performing well. Bank balance as of November 14, 2016, is \$45,440.

- 3. <u>A reminder to all presbytery committees</u>: all presbytery expenses must be paid by voucher (with supporting documentation) upon approval of the presbytery committee

moderator and subsequent review of the Administration and Budget Committee moderator.

- 4. Things to know about the General Assembly and the Synod of Living Waters per capita:
 - a. The General Assembly per capita is \$7.12 (2016) per church member, as recorded on your annual statistical report. (Read more about it here: http://oga.pcusa.org/section/departments/per-capita/)
 - b. The Synod of Living Waters per capita is \$3.62 (2016) per church member, as recorded on your annual statistical report.
 - c. The combined General Assembly and Synod of Living Waters per capita is \$10.74 per church member. Holston Presbytery is required by the Book of Order to give the full per capita to the General Assembly and the Synod of Living Waters—even when congregations withhold their giving to the presbytery.

TRUSTEES REPORT was given by Rich Fifield.

INFORMATION:

- 1. The Trustees received the 2015 Audit Report. A 2015 Financial Review Taskforce, composed of ruling elder Joe Chambers, and teaching elders Gary Kelly and Pat Willard, completed the 2015 presbytery financial review and their analysis did not discover any material modifications that should be made to improve the accuracy of the 2015 financial statements of Holston Presbytery. The report was accepted by the Administration and Budget Committee with much gratitude for the Taskforce and for the record keeping of the presbytery Treasurer.
- 2. The 2016 Tennessee Annual Corporation Report Form was updated.
- 3. The Trustees reviewed the presbytery's assets, including the Indian Ridge Church mortgage. This is a promissory note secured by deed. The original amount being \$195,000 dated November 23, 1999 through May 2032. Payments are \$500 per month at 0% interest. These payments are divided by action of the presbytery as follows: 50% to Youth Ministry Endowment; 25% to Hawkins County Ministry; and 25% to Church Hill Undesignated.
- 4. The Trustees reviewed the presbytery's insurance coverage as mandated by *G-3.0112*Insurance Each council shall obtain property and liability insurance coverage to protect its facilities, programs, staff, and elected and appointed officers.
- 5. Regarding the use and potential sale of the real property connected with the Walkertown Presbyterian Church (referred to the Holston Presbytery, Inc. Trustees by the Presbytery): An appraisal of the property was provided by the Walkertown Church; a title search was authorized by the Trustees. The Trustees are moving forward in performing the due diligence required by the Presbyterian Church (USA) property trust clause in the *Book of Order*.

- 6. Regarding the use and potential sale of the real property connected with the Bethany Presbyterian Church (referred to the Holston Presbytery, Inc. Trustees by the Presbytery): An appraisal of the property was authorized by the Trustees; a title search was authorized by the Trustees. The Trustees are moving forward in performing the due diligence required by the Presbyterian Church (USA) property trust clause in the *Book of Order*.
- 7. Grays Chapel, Roan Mountain, TN, will seek dissolution by the end of 2016. The Trustees authorized the Trustees' President and the Presbytery Treasurer to take all necessary steps to secure the property.
- 8. The Trustees ratified the opening of a Holston Presbytery brokerage account at Raymond James to receive donations of stock, and authorized the Presbytery Treasurer's signature on the account.

RECOMMENDATION:

9. The Trustees and the Hebron Presbyterian Church Administrative Commission recommend that Holston Presbytery grant permission to deed the Hebron Cemetery from the Hebron Presbyterian Church, Inc. to the Hebron Cemetery Association, Inc. and authorize Pamela Pope, President, Trustees, to execute all documents related to the property transfer. Approved.

- The Nominations Committee consulted with the presbytery Committee on Representation to provide for the rich diversity of the church and full participation in decision-making.
- 2. The process for nominations and elections is:

 - c. Uncontested nominees are elected by acclamation;
 - d. Contested nominees are elected by ballot.
