We have reviewed the statement of financial position of Holston Presbytery, Inc. (the "Presbytery"), a nonprofit Corporation, as of December 31, 2008, and the related statements of revenue and expenses for the year ended December 31, 2008. All information included in these financial statements is the representation of the management of the Presbytery.

A review consists principally of inquiries of Presbytery personnel and analytical procedures applied to financial data. It is substantially less in scope than an audit in accordance with generally accepted auditing standards, the objective of which is the expression of an opinion regarding the financial statements taken as a whole. Accordingly, we do not express such an opinion.

Based on our review, we are not aware of any material modifications that should be made to the financial statements in order for them to be in conformity with the cash basis of accounting which is a comprehensive basis of accounting other than generally accepted accounting principles.

INFORMATION:

1. Pursuant to the *Book of Order* G-11.0100b. requiring that the number of resident ministers entitled to vote in the presbytery not be greater than the number of elders so entitled, as of December 31, 2009 Holston Presbytery had 70 resident ministers, with 88 elders (68 elder commissioners, 20 Level II and Level III Commissioned Lay Pastors) so entitled to vote, thus there is no imbalance that needs to be redressed. (See attached Rolls)
2. The 2008 Minutes of Holston Presbytery were approved by the Synod of Living Waters without exception.
3. A report from the Commissioners to the Synod of Living Water's annual meeting in January 2010 has been received (see attached.)
4. Received a letter from the Stated Clerk of the General Assembly, Gradye Parsons, thanking Holston Presbytery for their full remittance of General Assembly per capita money in 2009.

Whenever the permanent judicial commission reports its inability to obtain a quorum, the stated clerk shall immediately select, by rotation from that roster, a*

sufficient number of former members of the permanent judicial commission to constitute a quorum. The stated clerk shall report the roster annually to the governing body.

**Synod Commission's Report
Annual Synod of Living Waters Report
January 2010**

We attended the synod meeting on January 25th in Franklin, TN. Interesting items include:

1. Dr. Richard Borie was installed as the new synod stated clerk. Dr. Borie has been stated clerk of North Alabama Presbytery since November 2005. His Ph. D is in physical chemistry and worked for Monsanto Company in technological management.
2. The Voice is on-line http://www.synodoflivingwaters.org/the_voice/
3. Synod staff is moving to a virtual office to reduce expenses.
4. Synod budget is fairly stable. Income for 2009=\$973,944 Expense for 2009=\$944,116. Budget for 2010: Income-\$976,076 Expense=\$975,659.
5. Holston received \$9,300 for campus ministry in 2009. Of the 12 campus ministries receiving funding from the synod, we are ranked 11th in terms of amount of funding received. Only the presbytery of North Alabama receives less. The synod also approved a ten percent reduction for campus ministry. We were told by Treasurer Terry Newland that the synod is "weaning" campus ministry from synod support.
6. Sabbatical grants from the Board of Pensions are available.
7. Applicants must have been in the presbytery for ten years, in his/her current congregation for 6 years, and the congregation must have less than 200 members. The grants are for \$3,000.
8. Go to www.synodoflivingwaters.org for application and rules.
9. Presbyterian Women meet June 6th in Huntsville, AL.
10. Living Waters for the World has increased its budget. The program is expanding. Go to www.livingwatersfortheworld.org for information.

- a. Clean Water U dates for 2010 in Oxford, MS are 3/10-14, 4/21-25, 7/6-10, 9/15-19. Also, Oakhurst, CA has a campus and its dates are 8/15-19 and 10/3-7.
 - b. 326 systems in 24 countries. 88 installed in 2008 and 73 in 2009. 1000 students have attended Clean Water U.
 - c. There were 18 treatment units in Haiti. Ten were destroyed. Two are working. Info on the other units was unknown as of this report. LWW plans to rebuild all of them and make them solar powered.
 - d. Good energy. Growing program. LWW increased its budget from \$353,152 in 2009 to \$553,446 in 2010.
11. General Assembly Commissioner training will be in Nashville, March 7-8. Contact St. Andrew Presbytery executive, Greg Goodwiller, to register and for information goodwiller@pcusa.org
 12. Harold Finley of FPC Jefferson City attended the meeting as commissioner along with me. Both Harold and I are on the committee that will oversee the sabbatical grants.
 13. The next meeting of the synod will be January 31st, 2011.

MINUTES OF THE COMMISSION of Holston Presbytery to install **Reverend Ike Brighton** as the Pastor of the *Blountville Presbyterian Church*, Blountville, TN.

The Commission, according to the appointment of Holston Presbytery, met at Blountville Presbyterian Church on Sunday, December 6, 2009 at 1:30 p.m. Commission minister members were Rich Fifield, Dan Clark and Fred Niles; elder members were Susan Smith (Waverly Road) and Danny Massey (Blountville).

Susan Smith was elected moderator and clerk and opened the meeting with prayer at 1:30 p.m. A quorum was declared. Responsibilities and procedures for the Service of Installation were reviewed, and the Commission recessed to be reconvened in the presence of the congregation at 2:00 p.m. with an agreement to adjourn at the benediction.

Rich Fifield opened the service with the Call to Worship and prayer. Susan Smith offered the Confession of Sin and Assurance of Pardon. Fred Niles read from Isaiah 40:25-31 and Philippians 4:4-9 and delivered the sermon "I Say, Rejoice." Rich Fifield delivered the sentences of Scripture and statement on the ministry of the Church. Constitutional questions to the pastor and congregation were delivered by elder Danny Massey in the affirmative. Prayer and declaration of installation were done by Rich Fifield and the charge to the pastor and congregation by Dan Clark.

**Administrative Commission for the Chuckey Presbyterian Church
Minutes – Thursday, December 10, 2009**

The eighth meeting of the Administrative Commission for the Chuckey Presbyterian Church was held in Johnson City, TN at the office of Chip Herndon at 5:30 p.m. on December 10, 2009. Present for the meeting were Commission members Chip Herndon, Rebecca Nunley, Dan Donaldson, and Jerry Ward. The meeting was opened with prayer by Dr. Donaldson and the minutes of the August 18, 2009 meeting were unanimously approved. It was noted that the Commission had attempted to meet previously on November 11, 2009, but a quorum of members was not achieved.

Dr. Donaldson opened discussion about the status of the church and reviewed circumstances concerning pulpit supply since the end of Kathleen Wright's ministry. Jackie Riddle has now assumed the responsibility of preaching at Chuckey due to the failure of Terry Sutherland to assume such duty. Ms. Riddle is also serving Amity Church and is coming to Chuckey after she finishes there.

Discussion took place regarding the question of whether or not the Church should be considered viable enough to sustain its operation as it currently exists. It was noted that there is some use of the building on Sunday evenings by the group "The Journey." A brief review of church finances was given which indicated fiscal soundness sufficient to sustain the maintenance of the building for a limited time if the church is closed. It was agreed that the Commission should gather further information about the situation of the church in two ways:

After the first of the year, Dr. Donaldson and Dr. Ward will meet with Elizabeth Love and share with her the formal evaluation of the Commission as voiced to the Presbytery in August, 2009; ask Ms. Love to formulate a plan/mission vision for the church for a period of six (6) months; and submit to Dr. Donaldson regular reports on church attendance and church programs.

After the first of the year, Ms. Nunley and Mr. Herndon will meet with Jackie Riddle and seek her evaluation and assessment of the current situation of Chuckey Church. They will share the thoughts and concerns of the Commission and seek her input regarding direction for the future.

It was agreed that Dr. Donaldson would find out from Ms. Riddle how long she would be willing to work as pulpit supply for Chuckey Church. If she is not willing or available to continue to nurture the church in her current role, then the Commission will need to immediately address the issue of sustaining the operation of the church.

A point of information was given concerning possible wind damage to the church building roof following the recent storm. Dr. Ward will contact the insurance carrier for the church and proceed with an evaluation of damages.

There being no further business, the meeting was adjourned with prayer by Dr. Donaldson. The next meeting of the Commission will be in early February and members will be notified of the date by email.

Faith Journey – Elizabeth Troyer

My family had a semi-nomadic lifestyle for most of my childhood. I was born in Clarksburg, but we moved shortly thereafter to Charleston WV, with stops in Ripley, Clarksburg again, and then Green Bank, WV, all before I graduated High school. I was perpetually the new girl! Every town had its own flavor and also its own unique church life. In some places, we were members of large congregations, fully staffed and fully programmed with a hundred kids running around the halls. In others, we were the only children in a very small congregation. All the moving taught me that God is the one constant of life, never changing, always present, whether my next door neighbor was an apartment building or a cow.

My mother served a Presbyterian congregation as a Director of Christian Education for many years, which means that I saw the inner workings of the church early in life. Also, as any child of ministry quickly learns, I became adaptable – Who didn't show up this time? I need to run home and get three rubber chickens? Ok! My mother provided an exceptional model of faith and service. The number of hours spent in classrooms while my mother of taught, the meetings where I sat in the back playing Game Boy, all of those opportunities I complained about as child have shaped my ministry and my person in ways I will never fully understand.

In Green Bank, my family joined in the only Presbyterian church around, one of three ten member churches that formed a parish. When one of our elders died, I stepped into that position, serving on our session for two years before I left for college. Becoming a fully-fledged elder at the age of fifteen was an interesting experience for my family and my church, but in the end, it taught all of us to never underestimate the skills and ability of the youth we know to serve along with us.

College was another shaping experience. Like many people I think, I experimented with the bounds of my faith. I tried everything on, Agnosticism, Buddhism, and with a roommate who was Wiccan some of that too. Nothing fit. I felt an emptiness and, as much as I tried to ignore it, God kept poking me,

reminding me. Friends that didn't know about my background would ask me questions about the faith, ask me to pray for them. I was confused. Until a professor, an English professor, asked me if I had thought about going to Seminary. I hadn't, but he got me an application anyway. So, I applied, it was better than getting a real job, right? But God always has plans.

Though seminary was a big leap of faith, no experience I've had since entering has signaled to me that it was the wrong one. Through my struggles with Greek, and my internships, and to my graduation, God has continually affirmed my decision to trust where God was leading. Looking back now, I can see the ways God was shaping me, leading me towards the ministry even when I tried to ignore it myself.

Statement of Faith – Elizabeth Troyer

Jesus the Christ is the Son of God, the light of the world, and the living and reigning Lord. In his Incarnation, life, death, Resurrection, and Ascension Jesus has taken humanity into his arms and carried us to the Father. In every moment, Jesus is actively interceding on behalf of humanity with the Father and on the Father's behalf to humanity. Jesus does for us what we cannot do for ourselves. Despite our fallen and sinful state, Jesus reconciles humanity with the God of love and honor; in the process he restores our broken and hurting relationships with God and each other.

God the Father is the creator and sustainer of the world. From the beginning, the Father has cared for and tended to the world and its inhabitants. Maintaining an active role in the creation, the Father reaches out and into the world to shape and reshape the creation. In the creative power of The Father's sovereign providence, the world and humanity is constantly being created anew and afresh, abundant with possibilities and new paths. God the Father has foreknowledge of the paths of time. In this knowledge, God the Father guides and directs us.

The Holy Spirit serves to unify us with Jesus the Christ. Through the communion of the Holy Spirit in our lives, it is possible for us to participate in the work of Jesus on this Earth. The Holy Spirit is the bond which brings us into communion with the Father and the Son, but also in Union with each other. The communion of the Spirit also means communion with the body of Christ. Our church and Christian communities are called and brought into being through the Holy Spirit.

This triune God has called the church into being. Each person in the Church has been called by God the Father, Son, and Holy Spirit with a reason and for a purpose. As a result, I respond by service and in humility. Reaching out in to the world as God's arms and legs allows me to participate in the ongoing ministry of Jesus Christ. The kingdom of God is both here and is to come. Therefore, the ministry of service will continue until the return of Christ when the world will be reconciled to God.

Trustees Report:

INFORMATION:

The Annual Meeting of the Trustees of Holston Presbytery for 2009 was called to order and opened with prayer by Rich Fifield at 4:00 p.m., Tuesday, September 8, 2009, in the offices of the presbytery. Trustees present were Walter Kirby, Coy Klepper, Dorman Stout, and Bill Wade. Absent were Marcia Porter and Tom Wilson. Also present were Rich Fifield, Presbytery Executive, and Kim Fifield, Treasurer.

A quorum was found to be present. The minutes of the previous meeting of September 23, 2008, were read and approved as corrected. Rich explained that the purpose of the meeting was to fulfill the responsibilities of the Trustees in regard to their oversight of the properties of the presbytery and to meet Tennessee state requirements for annual meetings of corporations.

Rich provided information on the Indian Ridge Church mortgage, a promissory note secured by deed. The balance of the note as of December 31, 2007, was \$146,500, and the payments per month of \$500 are distributed by action of the presbytery 50% to Youth Ministry Endowment, 25% to Hawkins County Ministry, and 25% to Church Hill undesignated.

Rich presented copies of the presbytery audit for the year 2007, prepared by Thrower, Blanton, & Associates of Norton, Virginia, noting that in their opinion the financial affairs of the presbytery had been properly conducted and fairly stated in the accounts of the presbytery. He also presented a Fund Balances sheet, showing the distribution of all funds held by Holston Presbytery as of July 31, 2009.

Documents were presented to the Trustees, showing that the presbytery has property, workers' compensation, and liability insurance coverage. It was noted that the recent increase in property assessments in Johnson City might make it advisable that the coverage on the presbytery properties in that city should be adjusted, and Rich and Kim indicated they would investigate.

Following these presentations, Rich asked if there were other questions. There were none, and it was mutually agreed that the meeting should be adjourned, Rich closing the session with prayer.

Application Instructions

Ethical Issues and Human Needs • Holston Presbytery

Purpose: The proposed activities shall provide food relief to poor people in either acute or chronic conditions of hunger with an eye to long-range solutions.

What Projects are included: Direct food ministries (food pantries, soup kitchens, shelters, etc.) and projects which provide safe drinking water.

Process: Grants are awarded through a three step process.

- 1) Application is to be completed by the sponsoring church and sent to the EIHN Committee for review.
- 2) If a grant is awarded, the sponsoring church will receive the funds from the office of Holston Presbytery for distribution to the recipient (if other than the church).
- 3) After funds have been disbursed, an acknowledgment letter is expected from the recipient within sixty days.

Qualifying Criteria:

- 1) Funds shall be used for providing food and/or safe drinking water.
- 2) All applications shall be submitted and endorsed by a congregation of Holston Presbytery.
- 3) Acknowledgment letter from recipient shall be received by the committee for future applications to be considered.

Additional Information:

Normally, grants shall not exceed the contribution (financial and/or personal involvement) of the applying congregation.

Grant Amounts:

Local grants will be considered for requests up to \$2,000 dollars.

International grants will be considered for requests up to \$5,000 dollars.

Grants will be disbursed annually in December. Applications must be received by July 15th to be considered. An acknowledgement card will be sent to the sponsoring church to show application received by Presbytery office. If you do not receive a card within a reasonable mailing time, please contact the Presbytery immediately.

General Assembly – Congregational Hunger Ministry Grants

The PHP provides matching grants of up to \$5000 to congregation supported hunger ministries which meet specific funding criteria. In general, the one-time grants are available for new hunger ministries of programs of existing hunger ministries which address the underlying causes of hunger as well as providing direct hunger relief. The grants match the contributions of local Presbyterian congregations (up to \$5,000). For a CHM grant application, call 1-800-334-0434

3. Design a marketing strategy.
4. Construct a new Maintenance Facility in a discrete and convenient location. Remodel current office/maintenance facility into enlarged office facility.
5. Construct a new adult/family lodge, designed to sleep 36 – 48 persons – including a large meeting facility, overlooking the recreation field near the current office/maintenance facility.
6. Develop a new Summer Camp Village in the woods between the barn field and Rustic Camp area and, if feasible, construct a pond in the barn field area.
7. Remodel, or possibly reconstruct, the cabins in the Center Area to include internal bathrooms and convert the Unit Center wash house into meeting space.
8. Replace the current Office with a new Welcome and Administration Center on the south (left) side for the road as one enters the site.
9. Explore the possibilities for exchanging the Upper Meadows parcel for another property of similar value, contiguous with HPC's owned or leased property that can be used programmatically.
10. Construct a new on-site staff residence on the edge of the Barn field.
11. Prepare for the possibility of ownership of the leased land.

The highlighted ones above have been worked on and/or completed.

Two cabins have been adopted and are ready to renovate this spring. First Presby. Kingsport and First Presby. Johnson City have each taken on a cabin to renovate. They will be paying for the addition of showers and toilets at a cost of between \$16,000 and \$20,000. They will bring work crews up to build the addition (Habitat style).

All bunk beds have been renovated and ready to receive 80 brand new inner spring mattresses thanks to a grant from the Mooneyhan Foundation. We have also received two gifts to pay for the new mattress covers at a cost of \$1,100. These should be in place later this spring.

Other improvements we hope to accomplish this year on the cabins will be to paint the inside and to add carpet. The cost per cabin will run about \$1,400.

We also plan to provide linens in all cabins: sheets, blanket, towels at a cost of \$50 per bed. If you would like to help with any of these projects, please contact the camp.

11:52 AM - **Institutions Committee Report:** Chair Sue O'Dell noted briefly the institutions with covenant relations with the presbytery. She introduced the President of Tusculum College, Dr. Nancy Moody, who gave their annual report to Presbytery.

INFORMATION:

1. Tusculum College's President, Dr. Nancy Moody will give their annual report to Presbytery.

2. **Colleges in Covenant with Holston Presbytery Day** is scheduled for **September 12**.
3. **Lees McRae College:** Lees-McRae is celebrating 110 years of educating young people. This year has seen a drop of enrollment and a difficult time with finances. However, after several painful monetary adjustments, the College is working with a balanced budget. The applications for enrollment for next school year are well ahead of the rate at this same time in previous years. Hopefully a new president will be announced by June 1st. Lees-McRae College is alive and well and looking forward to a bright future.
4. **Evergreen Ministries:** The number of individuals currently served in East Tennessee is approximately 130 which includes 76 served in the elderly program living in Greeneville, Kingsport and Johnson City. Sixteen individuals with disabilities is also served in this area. Evergreen's elderly program continues to thrive and grow throughout Tennessee but mostly in rural areas. The biggest challenge is finding qualified staff to support elderly clients in rural areas and to adequately train them to do so. Recently, Evergreen received a small grant to provide training geared toward caring for the elderly.

Evergreen is anxiously awaiting the upcoming budget hearings; there is a potential for significant cuts to providers like Evergreen. Establishment funds, which provided some support for individuals to move from institutions or the homes of their parents into their own homes, have been completely eliminated.

Evergreen celebrated 50 years of service in 2009 which included a celebration at First Church, Greeneville at which Representative Eddie Yokley presented a Proclamation on Evergreen's behalf.

5. **Grandfather Home for Children:** Changes to the state budget have had an enormous impact on our ministry in the past few months. The state of North Carolina cut its mental health funding by 50% and the Level III residential care funding by 90%. This has had the biggest impact on our Banner Elk residential campus. The total number of level III children permitted at any one facility was reduced to 16 and the length of stay limited to 120 days. (Previously we had 40 children for an average stay of 300 days.) Although we can't change the state's decision right now, we have done everything possible to protect the children in our care. Some 34% of children recently discharged from our campus and group homes were placed with Grandfather Home foster families (who are the best of the best!). Some 24% of the children discharged were able to return home or to a kinship placement.

We currently have 13 children living on our Banner Elk campus. The leadership staff of Grandfather Home is working to develop new and expanded services on the Banner Elk campus including: comprehensive mental health care for children and families, day treatment, and respite care for foster families. We are also building Campbell Cottage which will be a secure psychiatric treatment facility that will house up to 10 severely disturbed children. We anticipate this new facility opening in September of 2010. The Grandfather Academy is also in a process of transition and restructuring because our license as a NC charter school has not been renewed due to the low enrollment resulting from state changes temporarily reducing our residential population. The Academy has begun a successful day treatment class and is seeking to recruit additional students from the surrounding communities.

At the same time our foster care program is exploding! We currently serve 234 children in our six Community Services Clusters: Asheville, Smokey, New River, Gaston, Winston-Salem, and Raleigh. Our Community Services Clusters offer Therapeutic Foster Care, Family Foster Care, Adoption and Post Adoption Services, and Respite Foster Care. The Therapeutic Foster Care program serves children with mental health issues. We offer special training to our therapeutic

foster parents to help teach them techniques for de-escalation, behavior management, and positive reinforcement. We are also offering more therapy services for these children including intensive in-home therapy. Our case workers have a small case load and offer ongoing support to their families.

We ask that you keep Grandfather Home, our children and our staff in your prayers as we work our way through many difficult transitions to build a ministry that will continue to meet the needs of hurting children touching them with the love and healing power of Jesus Christ. 6. **Tusculum College:** Performance artist Dr. Al Staggs provided a unique view of various aspects of theology during the 2010 Theologian-in-Residence lecture series in February. Dr. Staggs explored a range of topics from the legacy of Dr. Dietrich Bonhoeffer to the role of laughter in life.

In January, Tusculum began testing as an official GED Testing Center, providing much-needed service on a regular basis to Greene County and surrounding communities.

Tusculum received national recognition through the achievement of one student in the classroom and on the football field. Jarrell NeSmith, of Russellville, AL, has been the recipient of countless college, conference, regional, and national honors in the past months. NeSmith, who graduated in December with a degree in pre-medicine, was the only NCAA Division II representative on the 2009 National Football Foundation National Scholar-Athlete Team, which included Heisman Trophy candidates Tim Tebow and Colt McCoy. The 16 student-athletes were finalists for the William V. Campbell Trophy, which recognizes college football's National Scholar Athlete of the Year. Each of the finalists, including NeSmith, received an \$18,000 post-graduate scholarship.

The economic impact of Tusculum College in Greene County was more than \$65.2 million in 2009, according to a recent study conducted by East Tennessee State University.

7. **King College:** This academic year has been one of transformation and growth at King, and marks the tenth year of record growth for the College. In fall 2009, we welcomed our largest student body ever, with a total of 1,804 students enrolled.

The 2009-2010 convocation series presented by the Buechner Institute has welcomed several nationally recognized speakers, including Walter Fluker, Maggie Jackson, and Holocaust survivor, Alfred "Freddie" Traum.

The third annual Buechner Lecture, an acknowledgement of the sources and mission of the Buechner Institute, took place January 23, and featured Ron Hansen, novelist, essayist, and screenwriter. The day's events were a continuation of a series honoring Frederick Buechner through a focus on the engagement of faith and culture.

The 2010 gathering began on January 22, with a performance by a professional drama troupe from Philadelphia, performing a play based on Buechner's "Godric." Events continued on the 23rd, with a discussion with Hansen after a viewing of the Brad Pitt movie based on Hansen's book in which he chronicled the life and death of the iconic outlaw, "The Assassination of Jesse James by the Coward Robert Ford." Hansen spoke to issues of faith and fiction at the Buechner Lecture later the same evening.

On Monday, March 1, 2010, best-selling author of "The Shack," William P. Young, will present "The Shack: Is God Really this Good?"
