### **INFORMATION:**

1. Pursuant to the *Book of Order* G-11.0100b. requiring that the number of resident ministers entitled to vote in the presbytery not be greater than the number of elders so entitled, as of December 31, 2010 Holston Presbytery had 71 resident ministers, with 72 elders (69 elder commissioners, 2 Level II and Level III Commissioned Lay Pastors under contract, 1 Presbytery Moderator) so entitled to vote, thus there is no imbalance that needs to be redressed. ### **Joan W. Gandy - Statement of Faith**

I am a Christian. With that claim, I affirm that Jesus Christ is Lord and – to borrow language from the Heidelberg Catechism – that I belong body and soul not to myself but to Jesus Christ, my savior. Christ sets me free to live joyfully, gratefully, and confidently as a child of God even in trying times and even though I am a sinner. I am confident of God's love for me. I am confident of God's love for the world.

At Creation, God spoke and God's Spirit blew across chaos and made sense and beauty out of it. God created men and women, who defied God, choosing in their God-given freedom to disobey their Creator. God loved humankind still; and God continues to love his children.

Early on, God chose a people called Israel to show the world divine love and light. Then, in time, God did a new thing, coming among humankind in the man Jesus of Nazareth. Jesus taught radical new ways for men and women to live, to love one another, and to love God. Inspired by the Holy Spirit, writers long ago recorded God's way with the world, telling Israel's story as well as the story of the birth, ministry, death, and resurrection of Jesus Christ. These words now are our Holy Bible, the living word of God, fresh and new for every generation.

Jesus, Son of God, fully human and fully divine, offered himself in sacrifice to redeem the sinful world through his death on a cross. He was raised from the dead, and then he appeared to some of his followers before ascending to God's realm. Jesus exhorted his small band of followers to take God's message of love, hope, and redemption throughout the world, promising that he would be with them always and that the Holy Spirit would direct their paths.

Even today, God gathers people as the Church, equipping them through Christ in the Holy Spirit to exhibit God's kingdom to the world through worship, fellowship, and acts of love, justice, and hospitality. The caring deeds of the Church in the world are acts of gratitude for God's grace and are testimony to God's promise of redemption and life eternal. God calls every generation to pass on the faith as a God-given inheritance.

God created the world good and intends the broken world to be mended. God calls us to respect the entire created world and act as stewards of it. In the fullness of God's time, the in-breaking of God's kingdom will be complete. Christ will come again. The broken world will be made whole. Creation will be healed. There will be no more tears and no more pain. The world then will be ever reconciled to God, and we will live in everlasting light and beauty in the company of God and angels.

### **Joan W. Gandy - Faith Journey**

A multi-generational family and a loving church family nurtured me as I grew in faith and became confirmed as a member of the Presbyterian Church early in my life. As a young person I felt a call to work in the church but felt shut out of full opportunity to pursue that call because of the denomination's reluctance to accept women as candidates for ministry in the Deep South at that time. I moved on to choose another life career. However, I continued to work in the church in numerous ways, finally serving as an elder.

During my work as an elder, I began to realize that the Holy Spirit might be calling me once again become a Minister of Word and Sacrament. I began to explore the call with the help of a pastor-mentor. At about this same time, however, my husband became very ill. I did not lose the sense of call to ministry but felt that I should accompany my husband in his fight against debilitating disease and sickness.

Two years after my husband's death, I began to explore once again the Spirit's call. I began to take online classes in the University of Dubuque Theological Seminary's master of divinity program. The more I studied and strived to discern God's will, the more certain I became that God was leading me to seminary and to a new way of serving the church. I enrolled in the M.Div. program at Columbia Theological Seminary in the summer of 2007 and graduated with the M.Div. degree in May 2010.

What a journey it has been for me since 2007! I thrived on the immersion into theological and biblical studies. With every semester, I felt my call affirmed. My spiritual awareness, knowledge of the Bible, sense of God's presence in my life, and confidence as a preacher and teacher grew. I experienced further affirmation during a summer ministry internship, in which I worked side-by-side with the pastor much as an associate minister of a church would do. And in a summer of Clinical Pastoral Education, I

sensed growth in my pastoral care skills, particularly my sense of call to be present in Jesus Christ's name for those in pain and grief.

For many years, I have been attentive to my own spiritual needs and Christian growth by setting aside early morning time for reading Scripture, praying, and meditating. When I became a member of the Company of New Pastors in 2009, my disciplines became newly meaningful as I began to use the daily lectionary for that time of prayer and study. I am a walker and that time of delightful exercise is a time for meditation, as well. Further, I have a small group of friends with whom I share ideas and concerns related to our faith journeys.

God calls me now to use my God-given gifts and experiences in service to the church as preacher, teacher, and pastor in a particular church. It is not without fear and trembling that I step into that call. As has been the case all along in my faith journey, Jesus Christ through the Holy Spirit, is my guide. Scripture and prayer light my path. Journeying with others who seek to exhibit God's kingdom to the world, I strive to follow in the way of the pioneer and perfecter of our faith.

  - b. Multiple requests for donations to the same organization within the same year will not be honored. If conflicts do arise, the Five Cents coordinator will contact churches and notify them that only one will be honored.

- c. Remove language in the cover letter that states churches may not request more money than they donate.

### Application Instructions

#### Ethical Issues and Human Needs • Holston Presbytery

**Purpose:** The proposed activities shall provide food relief to poor people in either acute or chronic conditions of hunger with an eye to long-range solutions.

**What Projects are included:** Direct food ministries (food pantries, soup kitchens, shelters, etc.) and projects which provide safe drinking water.

**Process:** Grants are awarded through a three step process.

- 1) Application is to be completed by the sponsoring church and sent to the EIHN Committee for review.
- 2) If a grant is awarded, the sponsoring church will receive the funds from the office of Holston Presbytery for distribution to the recipient (if other than the church).
- 3) After funds have been disbursed, an acknowledgment letter is expected from the recipient within sixty days.

**Qualifying Criteria:**

- 1) Funds shall be used for providing food and/or safe drinking water.
- 2) All applications shall be submitted and endorsed by a congregation of Holston Presbytery.
- 3) Acknowledgment letter from recipient shall be received by the committee for future applications to be considered.

**4) Organizations can receive a maximum of one grant per calendar year.**

**Additional Information:** Normally, grants shall not exceed the contribution (financial and/or personal involvement) of the applying congregation.

**Congregations are expected to contribute to the ministry of the organizations for which they request grants.**

**Grant Amounts:** Local grants will be considered for requests up to \$2,000 dollars. International grants will be considered for requests up to \$5,000 dollars.

**Local and International grants will be considered for requests up to \$2,000.**

Grants will be **disbursed annually in December**. Applications **must be received by July 15<sup>th</sup>** to be considered. An acknowledgement card will be sent to the sponsoring church to show application received by Presbytery office. If you do not receive a card within a reasonable mailing time, please contact the Presbytery immediately.

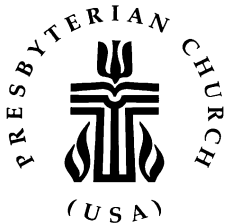

**Institutions Committee Report:** Sue O’Dell introduced Jim Swinkola and Mae Weed for Grandfather Home’s annual report. Angus Shaw closed their report with prayer.

**INFORMATION:**

1. **Evergreen Presbyterian Ministries** – has a total of 108 East Tennessee individuals which includes 70 served in the elderly program and 48 served in the Developmental Disabilities program. ● East Tennessee staff was busy preparing for the state’s annual survey visit in January which ensures that we are providing high-quality services to clients. ● Evergreen’s elderly program continues to thrive and grow throughout Tennessee but mostly in rural areas. Some of the grant money from Holston Presbytery is going to be spent on helping one of our elderly folks build a ramp to get in and out of her house. She has been confined to her home due to mobility issues for the last 8 months except to attend doctor’s appointments. EMS has to come and pick her up and bring her home in these instances. The first thing she wants to do is get her hair “set” and to attend her home church of 45 years which she has not been able to attend due to her steps. The new ramp will give her life back and allow her to reconnect with her church family.
2. **Grandfather Home for Children** – would first like to thank all the churches of Holston Presbytery for the generous support of their ministry in 2010 which enables them to meet the needs of children that are no longer covered due to deep budget cuts from the state. Your generosity is a witness of the love of Christ to these kids. ● Campbell Cottage opened in mid-December and is serving 6 children who have been severely traumatized. It provides a secure environment with all activities in the cottage or the attached outside recreation area. Since they cannot leave the cottage to attend Sunday School or worship, the pastor of Arbor Dale Presbyterian Church, with a guitarist from his congregation, have begun offering a weekly worship, music, and study time. The kids have responded well and look forward to it every week. The church also brings in a special meal for the kids once a month. Two additional cottages are scheduled to open this

spring serving up to 6 children per cottage. ● 22 residential children are served in Banner Elk and about 250 children through Community Services Clusters in six locations which offer Therapeutic Foster Care, Family Foster Care, Adoption Services, and Post Adoption Services. Banner Elk's Grandfather Academy provides education for all residential kids as well as day students referred from the community. ● A milestone was achieved designating Grandfather Home as a Critical Access Behavioral Health Agency, a state certification based on the range and quality of mental health services offered to children and families. It recognizes the excellence of existing programs and permits expanding services to include Day Treatment programs and Intensive In-Home Treatment. ● Notify Presbytery office with recommendations for individuals interested in and able to serve as members of the Boards of Grandfather Home. ● An invitation is extended to congregations to use the Keener Family Support Center for small retreat groups. Contact Mae Weed, Director of Church Relations, for more information (828-260-7584, [m.weed@grandfatherhome.org](mailto:m.weed@grandfatherhome.org)). ● Grandfather Home is dealing with many changes but remains committed first and foremost to serving the needs of the children entrusted to their care. Please keep the children and staff in your prayers.

3. **King College** – Enrollment figures for the spring 2011 semester calculated that King College maintained a high overall student enrollment from the fall semester and a new record for spring enrollment with 1,833 students registered at the Bristol campus and its sites located throughout East Tennessee and Southwest Virginia—a 13% increase over the spring 2010 semester. In addition, King retained 94% of the undergraduate student population enrolled during the fall 2010 semester. ● U.S. News & World Report's 2011 edition of America's Best Colleges named King College among the Best Baccalaureate College's in the South for their 21st consecutive appearance. They are included in the Princeton Review's Best College rankings (7<sup>th</sup> year) and named a "Military Friendly School" by G.I. Jobs (2<sup>nd</sup> year) which names the top 15% of colleges, universities, and trade schools doing the most to embrace America's veterans as students. ● The Buechner Institute's annual Lectureship series continues with Cathleen Falsani, author, former religion columnist for the Chicago Sun-Times, on February 28 at Memorial Chapel at 10:30 a.m. and at Bristol Train Station at 7 p.m. ● King recently welcomed three-time Super Bowl Champion Bill Bates (former UT Vol; Dallas Cowboy) for a fundraising event with proceeds going to the Annual Scholarship Fund.
4. **Sunset Gap** – is gearing up for another summer of Work Camps. 2010 was a very successful year with the help of almost 1,000 volunteers from all over the United States who were able to build four new homes and repair 32 others. Several work groups have already signed up for 2011 starting with Penn State arriving in March. Sunset Gap is excited that some first time visitors will be arriving along with returning groups and that they are now able to accept credit cards.
5. **Tusculum College** – hosted the annual Theologian-in-Residence series in February with Dr. Clifton Kirkpatrick and Stated Clerk, Gradye Parsons exploring the changing world of mainline denominations. ● Three Tusculum professors, Dr. Angela Keaton, Dr. Antonio Bos and Dr. Michelle Freeman have recently been published in national academic journals in their respective fields. ● A Global Studies program has resulted in the creation of linked classrooms for discussing global business issues. In its first session, the connection was made with HIH University in Harstad, Norway and included its students studying abroad in Ghana, France, Germany and Chile and Tusculum students studying in Chile and Venezuela. ● Tusculum College focuses on clinical hours and practical experience in its teacher education programs with opportunities for field experience from the first course taken. As national publications recently called for more programs like those already in place at Tusculum, their program provides more than 200 clinical

hours of hands-on experience in a classroom before a student reaches the point of doing their student teaching.

6. **Jim Swinkola**, Grandfather Home for Children, will give their annual report.
7. The Institutions Committee requests that during September the congregations of Holston Presbytery focus on those institutions in covenant with Holston Presbytery. The committee recommends that a special offering be promoted during September and received on the last Sunday of September by the congregations within Holston Presbytery for the ministries of Sunset Gap Community Center, Evergreen Presbyterian Ministries, Tusculum College, King College and Lees-McRae College. The Thanksgiving Offering will continue to be received during November by the congregations for Grandfather Home for Children. Information about these institutions will continue to be available on the Holston Presbytery web site. Bulletin insert material will be available at the September 6<sup>th</sup> meeting of Holston Presbytery.
